Further, in terms of the "Code of Conduct to regulate, monitor and report trading by Designated Persons and immediate relatives of Designated Persons" adopted by the Company, and pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015 (as amended) read with the clarification given by BSE Ltd. on 2nd April, 2019, and the intimation dated 20th June, 2019 and 26th July, 2019 of the Company it is reiterated that the Trading Window had been closed from **Monday**, 1st July, 2019 and the same shall continue to remain closed till 48 hours after the financial results for the first Quarter of FY 2019-20 are approved at the adjourned Board Meeting to be held on 14th August, 2019 and become generally available.
