Scrutinizer's Report on Postal Ballot by way of remote e-voting

To, The Company Secretary Balmer Lawrie Investments Limited 21 Netaji Subhas Road, Kolkata-700001

Sub: Scrutinizer's Report on Postal Ballot through remote e-voting in respect of Passing of Resolution set out in the Notice dated 14th February, 2023

Dear Sir,

I, Navin Kothari, Practising Company Secretary (Membership No. FCS 5935, CP No. 3725) and Proprietor of M/s. N.K. & Associates, Company Secretaries had been appointed as Scrutinizer by the Board of Directors of Balmer Lawrie Investment Limited hereinafter referred to as the ("Company") for the purpose of scrutinizing the process of Postal Ballot conducted through remote e-voting ("e-voting") in a fair and transparent manner on the resolution contained in the postal ballot notice dated 14th February, 2023 ("Notice") issued pursuant to Section 110 read with Section 108 and other applicable Provisions, if any of the Companies Act, 2013 ("Act") (including any statutory modification or re-enactment thereof for the time being in force), read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") and in accordance with Regulation 44 and Regulation 17(1C) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ('SS-2') and in accordance with the requirements prescribed by the Ministry of Corporate Affairs ('MCA') for conducting postal ballot through remote e-voting vide General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 03/2022 dated May 5, 2022 and 11/2022 dated December 28, 2022 issued by the Ministry of Corporate Affairs (MCA) (hereinafter collectively referred to as ('MCA Circulars')

Report on Scrutiny:

- The Company had appointed Central Depository Services (India) Limited ("CDSL")
 as the service provider, for the purpose of extending the platform for remote e-voting
 to the Members of the Company for Postal Ballot.
- The service provider had set up remote electronic voting facility and Members had
 access the same at https://www.evotingindia.com. The Company had uploaded the
 Notice of Postal Ballot on the website of the Company, CDSL and also on the website
 of BSE Limited to facilitate their Members to cast their vote through remote e-voting
 only.
- The Management of the Company is responsible for ensuring compliance with the requirements of the Act and the Rules there under and SEBI Listing Regulations.
- My responsibility as the Scrutinizer of the voting process (through remote e-voting)
 was restricted to scrutinize the Postal Ballot by way of remote e-voting process in a
 fair and transparent manner and to prepare a Scrutinizer's Report of the votes cast in
 favour and against the resolution stated in the Notice of Postal Ballot based on the
 reports generated from the e-voting system provided by CDSL.
- As per the information provided to me and in conformity with the applicable regulatory requirements, the Notice of Postal Ballot was sent only through electronic mode i.e. e-mail to Members whose names appeared in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on Friday, 17th February, 2023 (end of day) (being the cut-off date).
- The Company had sent the Notice of the Postal Ballot along with the explanatory statement also containing the remote e-voting details by e-mail to Members whose e-mail addresses were made available by the Depositories or were registered with the Company as on the cut-off date. The Notices sent through e-mail contained the detailed procedure to be followed by the Members for casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and as provided in the MCA & SEBI Circulars.
- The Company completed the dispatch of Notice of Postal Ballot via e-mail to the Members on Tuesday, 21st February, 2023.
- As prescribed in the aforesaid Rules, the remote e-voting facility for the Postal Ballot was kept open for thirty days from Wednesday, 22nd February, 2023 at 9:00 a.m. to Thursday, 23rd March, 2023 till 5:00 p.m. (both days inclusive).

- As prescribed in clause (v) of sub rule 4 of the Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had also released an advertisement, which was published in English in 'Business Standard' newspaper having country-wide circulation on 22nd February, 2023 and in Bengali in 'Aajkal' newspaper on 22nd February, 2023 and in Hindi in Business Standard on 23rd February, 2023. The notice published in the newspaper contained the required information as specified in sub rule 4 (v) (a) to (h) (as applicable) of the said Rule 20.
- At the end of remote e-voting period on Thursday, 23rd March, 2023, at 5:00 p.m., the remote e-voting portal of the service provider was blocked forthwith.
- CDSL provided me the names, DP ID / folio numbers and shareholding of the members who had cast their votes through remote e-voting.
- The votes cast under remote e-voting facility were thereafter unblocked by me in the
 presence of two persons who acted as witnesses as prescribed under sub-rule 4(xii) of
 Rule 20 of the Companies (Management and Administration) Rules, 2014, (as
 amended).
- Thereafter, I as scrutinizer duly compiled the result of Postal Ballot by way of remote e-voting, the details of which are as follows:
